#### **Request for Price Quote Handrail Installation**

## I. Project Overview:

Grossmont Healthcare District is seeking quotes from qualified contractors for the installation of two ADA-compliant handrails on a set of two steps located on our property. The handrails must meet all applicable ADA standards for safety, accessibility, and durability. They must also have rounded ends for safety and be finished in black with a powder-coated, rust-resistant finish. This project is subject to prevailing wages requirements.

#### II. **Project Location:** 9001 Wakarusa St, La Mesa, CA 91944

# III. Scope of Work:

- Install two ADA-compliant handrails, one on each side of the two steps.
- Ensure proper alignment and installation, adhering to ADA guidelines.
- The space between the two posts is approximately 25.5 inches.
- Handrails must have rounded ends for enhanced safety and compliance.
- Handrails must be finished in black with a powder-coated, rust-resistant finish for durability and weather resistance.
- Provide all materials, tools, and labor required for the project.
- At least a 1-year parts and labor warranty are required for all work performed.

#### **IV.** Quote Requirements:

Interested parties must submit a quote in accordance with the following requirements:

- Detailed cost breakdown, including materials, labor, and any additional charges.
- Material specifications and confirmation of ADA compliance, including rounded ends for safety.
- Estimated timeline for project completion.
- Proof of appropriate licensing and insurance.
- Confirmation of compliance with prevailing wage law.
- Proof of publics works contractor registration through DIR's website.
- Three reference and contact information (email address) from similar commercial/public projects.

#### V. Evaluation Procedures:

Quotes will be evaluated by GHD staff based on the following criteria:

- Completeness and responsiveness to this RFQ.
- Cost and overall value.
- Contractor's or qualified firm's experience and qualifications
- Reference responses.
- Project timeline and ability to meet the specified completion date.
- Compliance with Prevailing Wage requirements.

#### VI. Award of Contract:

Grossmont Healthcare District reserves the right to accept or reject any or all quotes received. The contract will be awarded to the contractor whose quote is deemed most advantageous to the District. A decision selecting the successful contractor or qualified firm is expected to be made by the end of **February**, 2025.
